1.1. Purpose

The purpose of this document is to present a detailed description of the Learning Management System proposed for mLAC. It will explain the purpose and features of the system, the interfaces of the system, what the system will do, the constraints under which it must operate and how the system will react to external stimuli. This document is intended for both the stakeholders and the developers of the system and will be proposed to mLAC technical team for approval post internal approvals at Mind Path Innovations Pvt Ltd.

1.2. Scope of Project

This software system will be a cloud based Leaning Management System integrated with currently implemented Admissions, Examinations, Faculty & Student portals at mLAC. This system will be designed to maximize mLAC productivity by providing tools to assist in automating various processes, needs while remaining easy to understand and use.

More specifically, this system is designed to allow efficient levels of communication with key stakeholders, and easy documentation of various academic & administrative information.

Key Modules & Scope of work

1. Admissions

- a. Move existing admissions module to Microsoft Azure Cloud infrastructure
- Make necessary updates for web security requirements, data replication and backup
- c. Identify and accommodate additional data capturing / data fields in respective UI at various stages of admission process keeping in mind data requirements for NAAC / other accreditation and administrative purposes
- d. Integrate online / over the counter fee payments without additional overheads for data synchronization.
- e. Enable real-time reports on fee collection / balance status across




LMS Architecture

Introduction

This document captures the details of the e-campus system (eDMis) developed and implemented for Maharani Lakshmi Ammanni College for Women, under the software development agreement dated 11-08-2018.

The development activities spanned across ten months with a phased implementation plan covering various aspects of college administration and student life cycle.

Throughout the development phase, Developers & users of the software have put in considerable effort to automate repetitive tasks across the processes resulting in a highly flexible, user-friendly and efficient software platform tightly integrated across the modules.

Software Architecture


Developers of the software have followed the classic client-server architecture with MVC pattern considering the nature of application leveraging "Encapsulation" for frequent updates and deployments.

Development platform: Microsoft .NET framework v4.6 on Visual Studio with Microsoft ASP.NET MVC 5 as primary development platform for server side business logic.

Database Server: Microsoft SQL Server 2016

Web Server: Microsoft Internet Information Server (IIS) 7.5

Deployment and accessibility: Software has been deployed on Windows Server Environment on Dell PowerEdge server accessible over standard web browsers within college campus over LAN.
