The conduct of examinations in an autonomous system is an important academic activity and the Examination Cell of mLAC plays a key role in the assessment and the evaluation processes. The performance of a student is measured by various methodologies devised by autonomous regulations of the college and is exercised through the office of Controller of examinations. At each and every stage in the evaluation process, including Continuous Internal Assessment (CIA) and End Semester Examinations (ESE), Controller of Examinations (COE) along with Deputy Controller of Examinations (Dy. COE) monitor the performance of students and provide suitable guidelines to various departments from time to time.

The regulations governing autonomous examinations have been framed as per the guidelines of Bangalore University and University Grants Commission, (UGC).

An academic year is comprised of an Odd and an Even semester of 16 weeks duration. The academic performance of a student is evaluated through a letter grading system based on her performance in CIA and ESE and is awarded to a student in a course for which the student has registered.

Examination committee is constituted to review the functioning of the entire examination system. Three batches of UG & 4 batches of PG students have passed out of the autonomous system in year 2019, 2020, 2021(UG) and 2018, 2019, 2020 & 2021 (PG) respectively.

# Examination 2020-21

Of the multitude of milestones of mLAC, the most historical is the conferring of autonomous status to mLAC. Examination Cell of the college has been the site where the confluence of ideas, innovation and practice are seeded for achieving academic excellence. In autonomy, the Controller of Examinations is endowed with well-defined responsibilities and adequate authority to conduct fair and timely examinations as per the academic calendar of the college. The office of the examination is the nerve centre of the college and has been committed to develop an efficient and flexible evaluation system with emphasis on the Learning Outcome-based Framework that link evaluation to Institutional goals. Several initiatives are implemented to maintain fair and transparent processes and to instil high level of confidentiality during the entire examination processes.

Admission data of 726 students enrolled for undergraduate courses and 73 students enrolled for post graduate courses in June 2020 were scanned, uploaded through e-portal and verified for the validity towards their admission and the same was approved by the Bengaluru City University. Students of UG & PG Courses whose admissions were approved were allotted course-wise generated register number comprising of alphanumeric characters and a unique student ID. 721 students of UG courses and 73 students of PG courses appeared for the examination in Jan 2021.

**Methods of Evaluation:** Students of each semester are evaluated through two components of evaluations which are centralized and conducted as per the time schedule and timelines pertaining to the examination calendar.

- 1. Continuous Internal Assessments based Internal Examination (CIA)
- 2. End Semester Examination (ESE)

## 1. Continuous Internal Assessments based Internal Examination (CIA)

The CIA and ESE components of Examinations are conducted in the ratio 30:70 for most of the UG and PG Courses while for the humanities courses, the ratio is 50:100.

Two internal Assessment tests were conducted for all subjects of a semester for a duration of one and a half hour.

Assessment of CIA for all UG and PG subjects were based on

- Average marks scored in two internal assessments,
- Assignments
- Attendance, a minimum of 75% attendance was mandatory to appear for the examination,
- Self-study report pertaining to topics other than that covered in the syllabus.
- **2. End Semester Examination** work-flow occur in three phases. Pre-Examination phase, Examination phase and post-Examination phase which are integrated with each other.

## i. Pre examination phase: Step-wise implementation

Mandatory registry of students through dedicated student portal enabled students to obtain all examination related information through the portal.

- **a) Examination Calendar:** Notifications were issued as per the examination calendar and timelines were set with strict adherence to the calendar thus ensuring transparency and timely conducting of examination and declaration of results.
- b) Formation of BOE: Board of Examiners (BOE) were constituted for every department/Subject with the HOD as the chairperson of the Board. Two sets of question papers were set per subject, one by the internal and another by the external paper setters, both from the approved BoE panel of Examiners and the soft copy of the question papers set are password protected and sent to the controller of Examination.
- c) BoE scrutiny: Question papers set by the internal and external examiners were reviewed, scrutinized by the BOE panel of examiners comprising of BoE Chairperson, senior faculty, and external subject experts of reputation. The papers were checked for the level of difficulty and also confinement of the paper to the syllabus and moderated to ensure standards and to remove incongruities and inconsistencies in the QP setting.
- **d) Printing of the question papers:** Out of the two sets of question papers, one was selected at random by the controller of Examination and the same was printed using in-house printing infrastructure in the presence of Controller and Deputy Controller of examination alone and sealed in

the packets, labelled and placed in a cloth bag which was stitched and sealed with the signature of the controller of examination affixed and distributed as per time table to respective Chief Superintendent of examination.

**e) Hall Ticket Generation:** On the basis of examination registration, hall tickets were generated for the end semester examinations and uploaded in the student portal.

# ii. Examination phase: Step-wise implementation

- a) Generation of quick response code: To overcome the cumbersome procedure of coding and decoding, each student was allocated a QR code with an alpha numeric random number per subject which was printed on the sticker which had the students' register number with the QR code. QR code was removed from the sheet and stuck on the space provided on the facing sheet of the answer booklet. Register numbers were never written anywhere in the answer booklet.
- b) **Conduct of Examination:** The end examination was conducted for a duration of 3 hours in an offline mode and in accordance with the norms of the University and the entire process was monitored by the Chief Superintendent of examinations constituted for the purpose. The Examination for foundation courses were conducted using tablets/mobile phones.

# iii. Post examination phase- Step-wise implementation

- **a. Evaluation Boards:** Evaluation board was constituted for each paper and comprise of all the faculty members evaluating the paper. The board discussed the scheme of the question paper and the pattern of the valuation to ensure uniformity and standard in evaluation.
- b. Valuation and declaration of Results: The controller of examination appointed one valuation custodian and one deputy valuation custodian from the list of internal examiners eligible for

the purpose. Centralized valuation was done and 10% of the valued papers from each subject were reviewed after the evaluation and are re-checked for correct entry of marks and total marks. The marks were uploaded to the software provided and the credit points, grade points and finally the SGPA were calculated. The gracing system was followed as per Bangalore University norms and was implemented wherever applicable following which the results are declared.


