



disposing of the assests and properties of the obligers) are held and firmly bound to the president of India (herein after called the Government which term shall unless excluded by or repugnant to the context be deemed to include his successors and assigns) in the sum of Rs 35.0 Lakh (Rupees Thirty Five lakh only) well and truly to be paid to the Government on demand and without a demur for which payment the obligers firmly bind ourselves by these presents.
